Dear Shareholder,

The board of directors of the Fund (the "Board") hereby advises you of the withdrawal of registration of all non-institutional rebate paying share classes in the UK.

All capitalised terms used herein shall have as a rule, the same meaning as in the prospectus of the Fund (the "Prospectus").

1. Factual background

After extensive consideration and assessment, all non-institutional rebate paying share classes will no longer be registered in the UK.

The Board is therefore informing you by way of this notice of the withdrawal of registration of the following share class types with the Financial Conduct Authority ("FCA"), with effect as of 28 February 2025 (the "Deregistration Date"). Please see Appendix 1 for those share classes that are to be deregistered and currently are invested by UK investors.

2. Consequences of the withdrawal of recognition of the share classes

The share classes will no longer be marketed to the public in the UK with effect as of the Deregistration Date. Upon withdrawal of registration of the share classes on the Deregistration Date, the share classes will cease to be recognised by the FCA. Subscriptions into these share classes by investors in the UK will be restricted as of the Deregistration Date.

From the Deregistration Date onwards, any UK offering document specific to these share classes are for your personal use only and should not be deemed to be an offer or continued offer of these share classes in the UK.

Subsequent to the withdrawal of registration of the share classes in the UK, the share classes will continue to remain in existence if they are not fully divested and to be subject to the applicable Luxembourg/laws and supervision of *Commission de Surveillance du Secteur Financier* (the "**CSSF**").

After the Deregistration Date, the UCITS KIIDs for these share classes will still be available upon request as long as there are UK investors in the share class.

3. What are your options as a UK Shareholder?

As a UK Shareholder, your options are the following:

- (i) You may redeem your existing shares, free of any charge until the Deregistration Date; or
- (ii) You may switch your existing shares to share classes that remain registered in the UK, free of any charge until the Deregistration Date; or
- (iii) You may decide to maintain your investment after the Deregistration Date in which case you will remain invested into these share classes and are not required to take any action.

If you choose the third option and decide to remain invested in these share classes after the Deregistration Date, UK investors will no longer be able to make any further subscriptions into these share classes, with the exception of dividend payments being reinvested into the Fund.
