Applicant Agreement

The arbitration panel shall have no power to award non-monetary or equitable relief of any sort or to award or impose a

remedy that (i) is inconsistent with these terms and conditions or any other agreement relevant to the dispute, or (ii) could not be made or imposed by a court deciding the matter in the same jurisdiction. I expressly waive any right that I might otherwise have to obtain such relief in arbitration or in any other forum. The result of the arbitration shall be binding on the parties, and judgment on any arbitration award may be entered in any court having jurisdiction.
