SHARECLASS CLOSURE AND MANDATORY CONVERSION NOTIFICATION

Please read this letter carefully as it contains important information regarding upcoming changes to certain funds and any action you may need to take. We would encourage you to familiarise yourself with the changes.

In this letter, when we say 'we' or 'us', we mean abrdn Fund Managers Limited, the company that is currently responsible for managing and operating your investment.

What is happening?

We regularly review our range of funds and the share/unit class structures with the intention of offering better outcomes to investors, to ensure that they remain able to meet the needs of the investors and are appropriate in the current marketplace. As a result of this review, we will be making certain changes to the available share/unit classes in our UK authorised fund range ("Funds").

We are writing to notify you of our decision to close the Platform 1, Platform P Fixed and class M share/unit classes ("Platform Share Class") within the Funds on the dates specified in Appendix 1 to this letter (each an "Effective Date"). These changes will take effect by four tranches as noted in the four different Effective Dates. Any investor remaining in the applicable Platform Share Class on the relevant Effective Date will be subject to a mandatory conversion of their investment from the existing relevant Platform Share Class to the equivalent "Institutional Share Class" (incorporating the class I, Institutional and Institutional B Fixed share/unit classes as shown in appendix one).

We believe this change is in the best interest of the investors as, unlike the existing Platform Share Class, the Institutional Share Class do not incur a platform dealing charge and so the Institutional share classes have a lower (or consistent) overall charge (on-going charge figure (OCF)) with consistent investor rights. Both Platform and Institutional Share Classes are deemed 'clean' share classes under the Retail Distribution Review. There will be no additional charge associated with these mandatory conversions.

Can I act ahead of the mandatory conversion?

You may, if you wish, arrange bulk conversions yourselves from the relevant Platform Share Class to the equivalent Institutional Share Class (or any other continuing relevant share/unit class) prior to the Effective Date. There will be no charge attached to any conversion ahead of the Effective Date. The conversion can be arranged by sending your usual conversion request instruction to our Transfer Agent. The details for our Transfer Agent can be found here - https://www.abrdn.com/uk-funds-operating-guide.

If you do not do this, your holding will be mandatorily converted on the relevant Effective Date as noted above.

What happens if you do not want to move into the receiving share class?

As noted above, the Platform Share Classes are closing. Therefore, should you not wish to be part of the mandatory conversion it will be necessary for you to either redeem in advance of the relevant Effective Date or switch into a continuing share class of another Fund (free of switch charges) within our UK authorised fund range. If you redeem your holdings (free of redemption charges) you will receive your redemption proceeds within the usual timescales outlined in the relevant Fund's prospectus.

Please ensure you carefully read the Key Investor Information Document ("KIID") which includes details around the relevant fund and share classes, investment objectives, policies and applicable fees and charges.

Taxation

For UK resident shareholders a conversion between equivalent classes of shares within the same Fund should not constitute a disposal for capital gains.

For non-UK investors, the tax consequences of the conversion may vary depending on the law and regulations of your country of residence, citizenship or domicile. If you are in any doubt about your potential liability to tax, you should consult a professional financial or tax adviser.

A redemption or switch of your investment on or before the Effective Date could result in future tax filing obligations and you may have to pay tax on any gain you may make. We do not provide investment advice and we strongly recommend that you seek advice from a person who is authorised under the Financial Services and Markets Act 2000 to provide investment advice so that you understand how these changes affect you and your investment and your tax position.
