### **Publication of a circular**

At the general meeting, shareholders will be asked to approve share issuance authorities in relation to the Offer and the continued operation of the Company's dividend reinvestment scheme and to approve an amendment to the Company's articles of association in order to extend the date of the next continuation vote to the annual general meeting of the Company to be held in 2028.
